Bureau of Transportation Safety

Rick Olig reviewed the following information for members to review:

Area Safety Concerns

Dennis Buchholz discussed the following area safety concerns:

- Bridge just west of Greenwood on County Highway G is under construction; someone hit bridge and did not report it-will need to be re-inspected.
- Intersection of County Highway H and State Highway 73-People using it as a passing lane instead of a turn lane as someone turns westbound onto County Highway H.

Village of Granton, CTH K, and Romadka Avenue

Dennis Buchholz informed the committee that Granton has no available funds for any changes to fix the intersection. They currently have two (2) stop signs in a row for it.

Local Crash Reports and Wisconsin Crash Data

Dennis Buchholz stated that at the ABATE meeting-motorcycle rally, no accidents happened this year. He also stated that as of YTD, Wisconsin has 24 motorcycle driver fatalities, three (3) motorcycle passenger fatalities, and 17 pedestrian fatalities.

County Fatality Update

Patrol Captain Ramberg reported one (1) fatality since our last meeting:

On Tuesday, June 12, 2018 at approximately 3:28 PM, a pickup truck being driven by a 35 year old man was traveling eastbound on Twenty Six Road, east of Miller Avenue, in the Township of Loyal when it struck the rear of a silage wagon being pulled by a tractor driven by an 18 year old male also traveling east. The operator of the tractor was not injured. The driver of the truck was pronounced dead at the scene by the coroner. He was not wearing a seatbelt. Speed and traveling too fast for conditions appear to be the factors in the accident.
